STALLION SERVICE CONTRACT

The undersigned Mare Owner hereby agrees on this _____ day of _____ 200_____, to breed the mare named below to the Stallion _____ Registration # _____ for the 200_____ season (February 1 to July 1) subject to the following conditions:

- All breedings will be with cooled semen. Breeding season starts February 1 and ends July 1. We collect semen from our stallions every other day **including weekends and holidays**. It is the mare owner's responsibility to call us and find out the collection days. Mare owner will be charged \$250 per shipment and an additional \$100 if semen is requested same day by air, counter-to-counter. Saturday and Sunday shipments must use the air shipment, as we do not have FedEx service on weekends. If your veterinarian feels your mare needs semen on a Monday, we will have to ship semen by air. The shipping charge is in addition to the stallion service fee which is:

- The stallion service fee includes a **non-refundable** booking fee of \$500. The **\$500 booking fee is due and must be paid in full upon** execution of this contract. The balance of the stallion service fee plus shipping fees and chute fee (if applicable) are due prior to shipping and must be paid in full before shipment will be made. No shipments will be made to a Mare Owner with a past due balance until the account is paid up to date. If twin embryos are successfully transferred on a single flush, Polo Ranch Stallions will provide a second Breeders Certificate for an additional fee of \$1,000. Polo Ranch Stallions must be notified of the twin flush within 15 days in order to provide the second Breeders Certificate. Twin flush must be by totally natural means. If fertility drugs are used, the second Breeders Certificate will be issued after payment of an additional stallion service fee.
- Polo Ranch Stallions does not charge an equitainer deposit; but, we do request that all equitainers are returned within 3 days. If the equitainer is not returned within 3 days, a \$25 per day fee will be charged until the equitainer is returned.
- This contract contains a "Live Foal Guarantee." A live foal is described as a newborn foal which stands and nurses without assistance. If the foal is born dead or does not stand and nurse without assistance, return privileges shall apply only if Stallion Manager is notified within seven (7) days thereof and receives a veterinarian's statement confirming death.
- If the mare proves not to be in foal as a result of the breeding contemplated by this contract, or the foal does not stand and suck as stated in the previous paragraph, the Stallion Manager, at its election, may either rebreed the mare the following year or refund the Stallion Fee paid pursuant to this contract, less the Booking Fee, thereby relieving the Stallion Manager to its obligation to rebreed the mare. Return privilege shall apply only to the next normal breeding period, from February 1 through July 1 of the following year. A \$500 administrative fee plus shipping costs will be charged for rebreeds and is due prior to shipping.
- A Breeders Certificate will be issued for the foal conceived by the mating when the Stallion Manager has been notified that a live foal has been produced and when stallion fees and all other expenses have been paid in full.
- Should the Stallion die or become unfit for service for any reason or if the mare should die or become unfit to breed, then this contract shall become null and void and both parties are relieved of any further obligation hereunder, and any monies paid by Mare Owner toward the Stallion Fee with the exception of the non-refundable Booking Fee, shall be refunded to Mare Owner. However, Mare Owner shall pay for all other expenses actually incurred.
- The Live Foal Guarantee in this contract is nontransferable and non assignable. Should the mare be sold or disposed of prior to the birth of the foal, the Live Foal Guarantee shall be void. However, Stallion Manager may, in its discretion, upon application and payment of a new Booking Fee, continue to honor the Live Foal Guarantee granted to the original owner. In the event Stallion Manager agrees to the transfer or assignment of the Live Foal Guarantee under the terms of this contract, then the new owner agrees to be bound by all terms and conditions hereof insofar as the same may then be applicable.
- Mare Owner agrees that Stallion Manager has not made and does not make any representation or warranty as to the quality or conformation of the foal or that the foal will be free of any infirmity, conformation defect, disease, or inherited trait. **STALLION MANAGER MAKES NO IMPLIED WARRANTIES OR MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.**
- The parties acknowledge that this agreement is made and shall be entirely performed within the State of Oklahoma, and shall be construed and enforced under the laws of the State of Oklahoma.
- The contract shall be binding upon the parties hereto upon execution hereof and the same may not be altered or amended, except by written mutual consent of the parties hereto.
- A photocopy of both sides of the registration papers on your mare must accompany this contract. The owner recorded on the registration certificate will be recorded on the stallion breeding report.
